

SUMMER VILLAGE OF GOLDEN DAYS

**RATES OF TAXATION FOR 2017
BYLAW NO. 252**

A BYLAW TO AUTHORIZE THE RATES OF TAXATION TO BE LEVIED AGAINST ASSESSABLE PROPERTY WITHIN THE SUMMER VILLAGE OF GOLDEN DAYS, IN THE PROVINCE OF ALBERTA, FOR THE 2017 TAXATION YEAR.

Whereas, the Summer Village of Golden Days, in the Province of Alberta, has prepared and adopted detailed estimates of the municipal revenue and expenditures as required, at the council meeting held on April 20th, 2017; and,

Whereas, the estimated municipal revenues and transfers from all sources other than taxation total \$ 55,951 and

Whereas, the estimated municipal expenditures and transfers (excluding non cash items) set out in the budget for the Summer Village of Golden Days, in the Province of Alberta, for 2017 total \$488,458 and the balance of \$ 432,507 is to be raised by general municipal property taxation and;

THEREFORE the total amount to be raised by general municipal taxation is \$ 432,507 and

Whereas, the requisitions are:

Alberta School Foundation Fund (ASFF)	
Residential/Farmland	\$ 282,881.00
Non-Residential	<u>\$ 2,640.00</u>

Whereas, Council of the Summer Village of Golden Days, in the Province of Alberta, is required each year to levy on the assessed value of all property tax rates sufficient to meet the estimated expenditures and requisitions; and

Whereas, the Council is authorized to classify assessed property and to establish different rates of taxation in respect to each class of property, subject to the *Municipal Government Act*, Chapter M26-1, Revised Statutes of Alberta 2000; and

Whereas, the assessed value of all property in the Summer Village of Golden Days, in the Province of Alberta, as shown on the assessment roll is:

Now therefore, under the authority of the Municipal Government Act, the Council of the Summer Village of Golden Days, in the Province of Alberta, enacts as follows:

1. That the Chief Administrative Officer is hereby authorized to levy the following rates of taxation on the assessed value of all property as shown on the assessment roll of the Summer Village of Golden Days, in the Province of Alberta:


2. That this bylaw shall repeal Bylaw 250 Rates of Taxation for 2016.
