

Mission Beach and Sunnybrook Transfer Station User Information Sheet

Golden Days Residents can purchase the **\$20 ONE TIME ACCESS CARD** from the Summer Villages Office only.

THE CARD ENTITLES THE BEARER TO ONE ACCESS TO THE SERVICES OFFERED AT THE SUNNYBROOK AND MISSION BEACH TRANSFER STATIONS ONLY. By accessing the transfer station, the user agrees to abide by County bylaws, policies, and procedures. Main requirements for access are prescribed below.

Transfer station access is based on residential use; therefore, commercial solid waste is not accepted.

The card must be collected by the County Transfer Station attendant prior to allowing access to Services at the site during site operating hours currently set as:

- **SUNNYBROOK (49164 RR 22) – WEDNESDAY, THURSDAY, & SATURDAY 9 A.M. TO 5 P.M.**
- **MISSION BEACH (1453 HWY 616) - WEDNESDAY 9 A.M. TO 5 P.M. & SATURDAY 9 A.M. TO 5 P.M.**

The suitability and quantity of Material shall be controlled at the discretion of the site attendant and is expected to meet the following criteria:

- Load sizes are not to exceed a typical 8-foot (2.4 m) pickup box filled to no greater than a depth of 3 feet (0.9 m). Approximate total volume of up to 3.5 cubic yards (2.7 m³) only will be allowed per facility access.
- Vehicles exceeding three tons will not be granted access. Pickup trucks, cars, vans, and utility sized trailers will be granted access.

Materials **ACCEPTED AT THE MISSION BEACH** Transfer Station:

1. Residential household waste
2. Bluebag recyclables- newspaper, mixed paper including office paper, magazines and flyers, corrugated cardboard, box board, metal cans, milk containers, beverage containers, rigid molded plastic containers labeled #1 to #7.
3. Compost and yard waste (May 15 to October 15)
4. Miscellaneous materials – furniture, bed mattress, box springs, etc.

Materials **ACCEPTED AT THE SUNNYBROOK** Transfer Station:

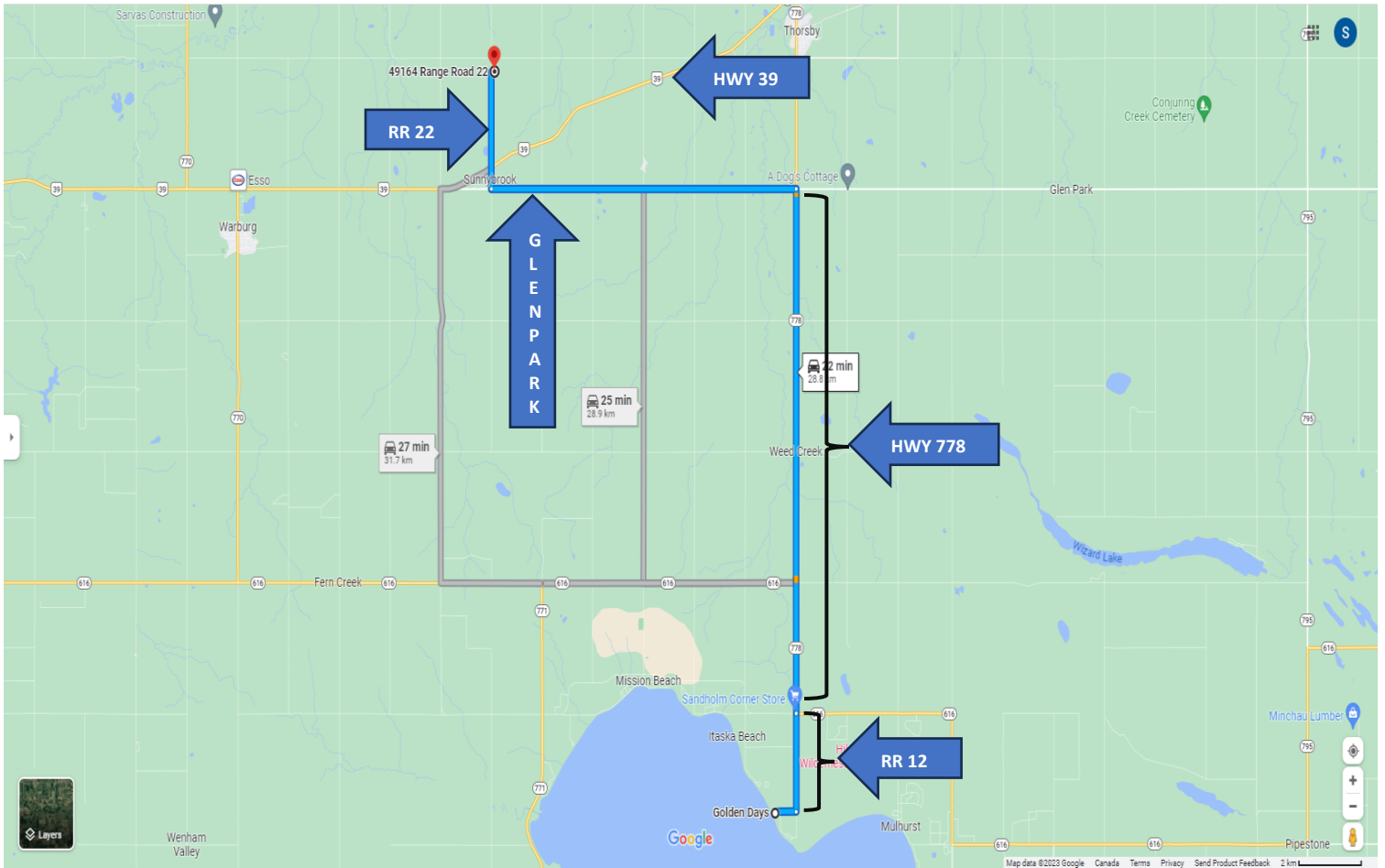
1. All materials accepted at the Mission Beach Transfer Station.
2. Household hazardous materials - used oil and filters, antifreeze, paint and oil containers, domestic cleaners, domestic pesticides etc.
3. Batteries - car, rechargeable and non-rechargeable, cell phone batteries etc.
4. Electronics - televisions, computers, monitors cell phones etc.
5. White metals - appliances, intact refrigerators, freezer, and enamel coated products etc.
6. Other metals - scrap metal, rebar etc.
7. Tires

Materials **NOT ACCEPTED AT THE TRANSFER STATION:**

1. Shingles
2. Dead animals
3. Other materials as described in the County Solid Waste Services Bylaw 02-17.

Vehicles transporting excessive volumes and excluded materials will not be granted access to the Services at the Leduc Solid Waste Transfer Stations and will be redirected to the Leduc and District Regional Waste Management Facility. Costs associated with disposal at the Leduc and District Regional Waste Management Facility shall be the responsibility of the resident.
